This event will be rescheduled for the fall. More information will be shared in the near future. Parks and Trails: Blue Zones Project was awarded funding to increase access to our parks and trails through the 10-minute walk campaign and safe routes to parks program. They are focusing on helping people find their way to parks and within our trail system through unified signage, engaging the community about our trails system, and learning about barriers to accessing our parks and trails. We have hired a consultant that will be putting together a wayfinding/signage plan, and we need input from the community on your needs- what trails you use, barriers to

- **Integral Youth Services:** Is trying to fill in the gap and provide meals for areas that are not served by the School Districts. - **Klamath Basin Senior Center:** (see email attachment for more information) Congregate meal sites is closed for now. They were serving 90-150 people a day previously. They have been collaborating with food bank, and have prepared 48 food boxes. AAA has also authorized the Senior Center to put ready meals in the boxes. The transportation program is still up and running, they are only serving one person at a time to respect social distancing. Meals on wheels' is also still in operation. The National Guard may be able to help deliver meals in the near future. Currently the Senior Center is losing 29,000 a month in income that was coming in twice a week through bingo games and program donations.
- **Sky Lakes Medical Center Outpatient Care Management** is still running. Staff are currently working remotely and checking on patients regularly via phone.
- **Friends of the Children:** They are still remotely to serving our youth. They are currently conducting family needs assessments to meet basic needs. They are also putting together kits for families and need donations for the care kits. They are looking for non-perishable food items, board games and activities.
